

Chapter 4- “The Rising Eye”

Aunt Best - **F**; member of the Lyte family; “a horrifyingly ugly, cross old woman...[w/] whiskers and toothless gums (73 hardcover; 81 green; 93 paperback)

Sewall- **F**; young clerk in Mr. Lyte’s office (66-68 hardcover; 73-75 green; 86-87 paperback)

Josiah Quincy- **H**; lawyer Rab gets to represent Johnny for free; often writes for the *Observer*

Justice Dana- **F**; a judge who heard the case between Johnny and Mr. Lyte

35. When Johnny tells Merchant Lyte that he is related, Merchant Lyte does not act kindly to him until Johnny mentions his **cup (68)**. Merchant Lyte then tells him to **describe the cup and then asks Johnny to bring the cup to his house that night “an hour after candles are lit” (68-69 hardcover; 76 green; 86-87 paperback)**.

36. Rab warns Johnny that Merchant Lyte is “**crooked**” and “**sly.**” “**He’s trying to ride two horses - Whig and Tory.**” (71 hardcover; 78-79 green; 90 paperback).

37. Colonists who believe that taxation without representation is tyranny are called **Whigs**. Colonists who believe that all of their differences with England and the government can be settled peacefully are called **Tories**. Rab is a **Whig**. (71 hardcover; 79 green; 90 paperback)

38. Rab lends Johnny **a clean shirt made of fine linen and a corduroy jacket w/ silver buttons (72 hardcover; 79 green; 91 paperback)** for his meeting with Merchant Lyte.

39. What does Merchant Lyte accuse Johnny of doing? **Stealing his cup (75 hardcover; 82-83 green; 94-95 paperback)**

40. Johnny gets special treatment in jail because **Rab is his friend and is a Sons of Liberty member. And as “both the turnkey and the jailer were also ‘sons’...Johnny was given a**

neat, private room on the ground floor.” (78 hardcover; 85 green; 97-98 paperback)

41. **Josiah Quincy (II)** offers to be Johnny’s lawyer for free. What witness can swear to seeing Johnny’s cup before the date on which Mr. Lyte claims it was stolen? **Cilla (78 hardcover; 85-87 green; 99-100 paperback)**

42. What witness can swear to seeing Johnny’s cup before the date on which Mr. Lyte claims it was stolen? **Cilla (78 hardcover; 85-87 green; 99-100 paperback)** What has Merchant Lyte done to be sure she will not testify for Johnny? **He has bribed the Laphams with a big order for silver and a promise for an additional order “if all went well.” (In other words, as long as they don’t help Johnny) (78 hardcover; 86 green; 98-99 paperback)**

43. Merchant Lyte testifies that his great-grandfather had six identical cups made in England, and gave one to each of his sons. **Four** of the cups came to America, and on August 23rd his own had been **stolen (81 hardcover; 89 green; 102 paperback)**. He suggests **the death penalty (82 hardcover; 90 green; 103 paperback)** as punishment for Johnny.

44. What is the outcome of the trial? **Merchant Lyte is proven to be a liar.** What happens to Johnny’s cup? **It is returned to Johnny. (83-84 hardcover 91 green; 105 paperback)**

45. After the trial, how does Isannah apologize to Johnny, and how does Johnny react? **“She bent and kissed his burned hand. He said nothing. He was suddenly afraid he might cry.” (84 hardcover; 92 green; 106 paperback)**
